Terms of reference

職責

- To make recommendations to the Board on all matters relating to the training and accreditation of travel agency personnel, including tour escorts and tourist guides, with a view to enhancing the professionalism of the trade.

Composition

- The Committee is composed of members from member travel agents and non-travel agents.

- Observers may be invited to committee meetings on a fixed-term or ad hoc basis, but they are not allowed to move a motion or vote at the meetings.
